

MUSICAL PERFORMANCE AGREEMENT

This AGREEMENT is made and entered into this first day of July, 2026,
BY AND BETWEEN

hereinafter referred to as the “Company”
AND

hereinafter referred to as the “Artist”

NOW AND THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties hereby agree as follows:

Article 1 (Scope of Agreement)

The Company hereby engages the Artist to give a musical performance for Chosaku Kenzo’s concert (hereinafter referred to as the “Show”). The details of the Show including dates, venues, locations and performance time are stipulated in the schedule attached hereto. The Artist hereby accepts such engagement on the terms and conditions set forth herein.

Article 2 (Payment)

In consideration of the services rendered by the Artist hereunder, the Company shall make the following payment including the withholding tax.

Rehearsal: US \$ _____ × ____ days = US\$ _____
Concert : US \$ _____ × ____ days = US\$ _____

Article 3 (Accommodations and Transportation)

- (a) The Company shall provide, at its sole cost and expense, the following for the duration of the concert tour:
- (1) One (1) round-trip business class air ticket between New York and Narita.
 - (2) Internal transportation between the airport and the hotel, and the hotel and the venues.
 - (3) Hotel accommodations.
- (b) The Artist shall be liable for all personal expenses, including but not limited to meals, telephone charges, personal travel expenses and incidentals.

Article 4 (Visa)

The Artist shall be responsible for procuring the necessary visas, passports and other necessary travel permits for the Artist to perform at the Show hereunder. The Company shall assist the Artist in securing such visas by processing the paperwork relating to any permission or approval required by the Japanese government. If the required visas and permits are not obtained on or before December 31, 2026 due to the Artist’s negligence, the Company may terminate this Agreement, and the Artist shall promptly refund to the Company any money the Company has paid to the Artist.

Article 5 (Prohibition on Use of Drugs)

The Artist hereby represent and warrants that (i) no illegal drugs shall be used, brought or distributed at any time during the Artist’s travel between New York and Japan, or during the Artist’s stay in Japan, and (ii) the Artist shall comply with the rules and regulations at the hotels and venues at which the Artist stays and

performs, and shall not violate any laws of Japan.

Article 6 (Name and Likeness)

The Artist hereby grants to the Company the non-exclusive right to use and permit others to use the Artist's name (including any professional name), likeness, signatures, and biographical materials for purposes of advertising, promoting, and marketing the Show.

Article 7 (Indemnity)

- (a) The Artist shall indemnify and hold harmless the Company from and against all actual losses, liabilities, damages, deficiencies, costs and expenses (including reasonable attorneys' fees) reasonably attributable to the breach of any representation, warranty or any other obligations of the Artist hereunder.
- (b) The Company shall indemnify and hold harmless the Artist from and against all actual losses, liabilities, damages, deficiencies, costs and expenses (including reasonable attorneys' fees) reasonably attributable to the breach of any representation, warranty or any other obligations of the Company hereunder.

Article 8 (Good Faith Consultation)

Any matters not addressed herein, or any doubt or uncertainty hereunder, shall be resolved through good faith consultation between the parties hereto.

Article 9 (Force Majeure)

Neither party shall be liable to the other party for any delay or failure in performing its obligations hereunder due to causes beyond its reasonable control, including but not limited to act of God, acts or orders of governmental authorities, fire, flood, typhoon, tidal wave, earthquake, war (declared or not), rebellion, riots, strike and lockout.

Article 10 (Termination)

If either party defaults in the performance of this Agreement, the non-defaulting party shall have the right to terminate this Agreement by written notice. Termination of the Agreement shall not affect the rights or the remedies available to the non-defaulting party.

Article 11 (Entire Agreement)

This Agreement sets forth the entire understanding and agreement between the parties as to the matters covered herein, and supersedes and replaces any prior undertaking, statement of intent or memorandum of understanding, in each case, written or oral.

Article 12 (Governing Law and Jurisdiction)

The parties hereby consent to and confer exclusive jurisdiction upon Tokyo District Court over any disputes arising out of or relating to this Agreement. This Agreement is governed by and construed in accordance with the laws of Japan.
